## **NOTICE OF HEARING**

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

### APPLICATION LANDS

Township 4 South, Range 64 West, 6<sup>th</sup> P.M. Section 26: All

#### <u>APPLICATION</u>

On March 24, 2017, Bison Oil & Gas, LLC (Operator No. 10618) ("Bison" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S., for an order to:

- 1) Amend Order No. 535-313 to allow an additional fourteen wells for a total of up to 16 horizontal wells within the established approximate 640-acre drilling and spacing unit covering the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 2) Maintain the 460-foot unit boundary setback established by Order No. 535-313 for the drilling and spacing unit but amend the Order to allow the productive interval of each wellbore be located no closer than 150 feet from the productive interval of any other wellbore producing from the Niobrara Formation, without exception being granted by the Director.
- 3) Applicant states that the wells shall be drilled from no more than two wellpads within the unit, or from a legal location on adjacent lands.

• On May 6, 2013, the Commission entered Order No. 535-313 which, among other things, established two approximate 640-acre drilling and spacing units consisting of Sections 26 and 33, Township 4 South, Range 64 West, 6<sup>th</sup> P.M., and approved up to two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation with the treated interval of the wells to be located no closer than 460 feet from the unit boundary and no closer than 920 feet from the treated interval of any other wellbore within the unit, without exception being granted by the Director. The Application Lands are subject to this Order for the Niobrara Formation.
