On April 13, 2017, HRM Resources II, LLC (Operator No. 10548) ("HRM" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 560-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara and Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

a. Alma 1S-66-2524 19NH Well (API No. 05-001-10020) – Niobrara Formation – WSU #1; and

b. Alma 1S-66-2524 20CDH Well (API No. 05-001-10027) – Codell Formation – WSU #2.
