1) Pool all interests in four approximate 640-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara and Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. PC South 1S-66-2928-14NH Well (API No. pending) WSU No. 1;
- b. PC South 1S-66-2928-15NH Well (API No. pending) WSU No. 2;
- c. PC South 1S-66-2928-16CDH Well (API No. pending) WSU No. 3;
- d. PC South 1S-66-2928-17NH Well (API No. pending) WSU No. 4.
