<u>APPLICATION</u>

On May 25, 2017, amended July 14, 2017, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 520-acre drilling and spacing unit for DSU No. 1 of the Application Lands for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, and approve up to eight horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations and require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 150 feet from the treated interval of any other wellbore producing from the Codell and/or Niobrara Formations, and no closer than 460 feet from the northern, southern and eastern unit boundaries and 800 feet from the western unit boundary, without exception being granted by the Director;
- 2) Establish an approximate 720-acre drilling and spacing unit for DSU No. 2 of the Application Lands for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, and approve up to eight horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations and require the productive interval of the wellbore of any permitted wells in the unit to be located

no closer than 150 feet from the treated interval of any other wellbore producing from the Codell and/or Niobrara Formations, and no closer than 460 feet from the northern, southern and eastern unit boundaries and 990 feet from the western unit boundary, without exception being granted by the Director;

3) Applicant states that the wells will be drilled from one well pad located within the each of the units and/or from a legal location(s) on adjacent lands, without exception granted by the Director.
