## **APPLICATION**

On June 19, 2017, Bill Barrett Corporation (Operator No. 10071) ("BBC" or "Applicant"), filed a verified application pursuant to Commission Rule 503.b.(10) and the Colorado Oil and Gas Conservation Act for an order:

- 1. Deny Verdad's Application for Permit to Drill, Form 2, for the Hubbs 01N-64W-08-1H Well (Document Number 401268220) ("Well") filed with the COGCC for the Application Lands pursuant to Rule 318A.
- 2. Applicant also requests any such other findings and orders as the Commission may deem proper or advisable.

- Colorado Oil and Gas Conservation Commission Rule 503.b.(10) provides that for purposes of seeking relief or a ruling from the Commission on any other matter not described in (1) through (9) above, only persons who can demonstrate that they are directly and adversely affected or aggrieved by the conduct of oil and gas operations or an order of the Commission and that their interest is entitled to legal protection under the Act may be an applicant.
- On July 24, 2017, the Commission entered an Order from Docket No. 170500245 to establish an approximate 1,280-acre drilling and spacing unit for Sections 4 and 5, Township 1 North, Range 64 West, 6th P.M., and approve up to 16 horizontal wells in the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations. The Verdad's pending APD for the Well falls within the

approximate 1280-acre drilling and spacing unit established by the Order.

Certain provisions of the Colorado Oil and Gas Conservation Act, C.R.S 34-60-101, et seq. apply to this Application, including but not limited to C.R.S. 34-60-116(2) and C.R.S. 34-60-117(a).
