APPLICATION

On June 23, 2017, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,923.32-acre drilling and spacing unit for the Application Lands, and approve up to 26 horizontal wells in the unit for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations;
- 2) Provide that the productive interval any horizontal well shall be no closer than 460 feet from the boundaries of the unit and not less than 150 feet from the treated interval of another well within the unit, and approve up to three well pads within or adjacent to the unit, unless an exception is granted by the Director.
- 3) Applicant states that the wells shall be drilled on no more than three well pads within the unit subject to Rule 318A or on adjacent lands, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units

for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with permitted well locations in accordance with the provisions of Order No. 407-1. The Application Lands are subject to this Order for the Codell and Niobrara Formations.


