### <u>APPLICATION</u>

On June 30, 2017, amended August 3, 2017, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,183-acre drilling and spacing unit for the Application Lands and approve up to 26 horizontal wells in the proposed unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations; and
- 2) Require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit.
- 3) Applicant states that the wells shall be drilled from no more than two well pads within the unit subject to Rule 318A. or on adjacent lands, unless an exception is granted by the Director.
- 4) For such other findings and orders as the Commission may deem proper or advisable in this matter.

 On April 27, 1998, the Commission adopted Rule 318A, which, among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all of the Cretaceous Age Formations from

the base of the Dakota Formation to the surface. On December 5, 2005, Rule 318A was amended to allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Rule 318A was amended to, among other things, address drilling of horizontal wells but did not prohibit the establishment of drilling and spacing units within the Greater Wattenberg Area. The lands encompassing the Application Lands are subject to Rule 318A for many of the wells drilled and producing in the Codell and Niobrara Formations.

 Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. The Application Lands are subject to Rule 318.a. for the Codell and Niobrara Formations.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 28, 2017. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
