APPLICATION

On July 11, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S. for an order to:

- 1) Pool all interests in an approximate 270.62-acre designated horizontal wellbore spacing unit, for the development and operation of the Niobrara Formation; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in § 34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Snowmass 2N Well (API No. 05-123-44887) ("Well").

APPLICABLE RULES AND ORDERS

- Rule 318A, as amended on August 8, 2011 addresses the drilling of horizontal wells under Rule 318A.a.(4)D. Rule 318A was originally established on April 27, 1998 to allow for certain drilling locations to drill or twin an existing well, deepen a well, or recomplete a well. Rule 318A also provided for the commingling of any or all of the Cretaceous Age formations from the Dakota formation to the surface. Rule 318A was first amended on December 5, 2005 to allow for interior infill and boundary wells and spacing units.
- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara formations, the Codell formation, and the Niobrara formation underlying certain lands.

including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1.

On February 14, 2017, the Commission also entered Order No. 407-1890, which, among other things, pooled all non-consenting interests in a 480-acre wellbore spacing unit for the E½W½, W½E½ of Section 5 and E½NW¼, W½NE¼ of Section 8, Township 5 North, Range 64 West, 6th P.M., for the Ehrlich 5M-243 Well (API No. 05-123-43547), from the Niobrara formation. Order No. 407-1890 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.
