# **APPLICATION**

On or before July 13, 2017, ConocoPhillips Company (Operator No. 19160) including its wholly owned subsidiary Burlington Resources Oil & Gas LP (Operator No. 26580) ("COPC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in the Application Lands underlying an approximate 1,280-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Aspen 3-65 15-14 3H\_D well (API No. 05-001-10007) and the Aspen 3-65 15-14 2DH well (API No. 05-001-10008) ("Wells").

On October 24, 2016, the Commission entered Order No. 535-742 which, among other things, established an approximate 1280-acre exploratory drilling and spacing unit for the Application Lands and approved a total of up to two horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, providing that the productive interval of the wellbore shall be located no closer than 460 feet from the unit boundaries, without exception granted by the Director, and providing that the productive interval of the wellbores shall be no closer than 150 feet from the productive interval of any other wellbore located in the unit, without exception granted by the Director.
