NOTICE OF HEARING

APPLICATION

On July 13, 2017, Bison Oil & Gas II, LLC (Operator No. 10661) ("Bison" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate an approximate 640-acre drilling and spacing unit established by Order No. 535-277 for Section 22, Township 8 North, Range 60 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from the Codell-Niobrara Formation;
- 2) Establish an approximate 960-acre drilling and spacing unit for the Application Lands, and approve up to 20 horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 3) Require the productive interval of the wellbore of each wellbore in the unit to be no closer than 600 feet from the unit boundary, and no closer than 100 feet from the productive interval of any other wellbore located within the drilling and spacing unit, unless an exception is granted by the Director.
- 4) Applicant states that the wells be drilled from no more than three well pads located within the unit, unless an exception is granted by the Director.

APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.

- On March 8, 2011, the Commission entered Order No. 535-277, which established an approximate 640-acre drilling and spacing unit for Section 22, Township 8 North, Range 60 West, 6<sup>th</sup> P.M., and approved one horizontal well, for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formation, with the treated interval of the wellbore to be located no closer than 600 feet from the unit boundaries and no closer than 150 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S. and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:



One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of August 28, 2017.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
