APPLICATION

On July 13, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1) Pool all interests in two approximate 560-acre horizontal wellbore spacing units established for the Application Lands for the drilling of the McGlothlin Farms 4W-234 well (API No. 05-123- 44003), and the McGlothlin Farms 4W-404 well (API No. 05-123-44004), for the development and operation of the Niobrara and Codell Formations.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the permitted well locations in accordance with the provisions of Order No. 407-1.
