<u>APPLICATION</u>

On July 13, 2017, Bison Oil & Gas II, LLC (Operator No. 10661) ("Bison" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in a proposed approximate 960-acre drilling and spacing unit, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Castor 8-59 19-24 13 Well, Castor 8-59 19-24 15 Well, and the Castor 8-59 19-24 16 Well ("Wells").

APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On September 23, 2011, the Commission entered Order No. 535-69, which established 40 approximate 640-acre drilling and spacing unit for lands in Townships 7 North through 9 North, Ranges 58 West to 61 West, 6th P.M., and approved two horizontal wells within each unit, for the production of oil, gas, and associated hydrocarbons from

the Niobrara Formation, with the treated interval of the wellbore to be located no closer than 600 feet from the unit boundaries, without exception being granted by the Director.

 On July 13, 2017, Applicant filed a Concurrent Application in Docket No. 170900568 for an order to establish an approximate 960-acre drilling and spacing unit for the Application Lands, and approve up to 16 horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
