On July 13, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1) Pool all interests in one approximate 280-acre horizontal wellbore spacing unit and one approximate 320-acre horizontal wellbore spacing unit established for the Application Lands for the drilling of the McGlothlin Farms 4W-334 well (API No. 05-123- 44006), and the Wacker 10G-314 well (API No. 05-123-43569), for the development and operation of the Niobrara Formation.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the permitted well locations in accordance with the provisions of Order No. 407-1.
