1) Pool all interests in four approximate 200-acre horizontal wellbore spacing units and three approximate 400-acre horizontal wellbore spacing units established for the Application Lands for the drilling of the McGlothlin 9U-332 well (API No. 05-123-43952), the McGlothlin 9V-212 well (API No. 05-123-43949), the Wacker 10F-232 well (API No. 05-123-43561), the Wacker 10G-312 well (API No. 05-123-43566), the Wacker 10F-302 well (API No. 05-123-43564), the McGlothlin 9V-202 well (API No. 05-123-43953), and the McGlothlin 9V-312 well (API No. 05-123-43955), for the development and operation of the Niobrara Formation.
