Pool all interests in pool all interests in two approximate 280-acre wellbore spacing units and eight approximate 560-acre wellbore spacing units established for the Application Lands for the drilling of the Wagner 28N-W10HZ well (API No. 05-123-43472), the Wagner 28N-E10HZ well (API No. 05-123-43469) the Marrs 28N-10HZ well (API No. 05-123-43270), the Wagner 2C-10HZ well (API No. 05-123-43473), the Wagner 27C-10HZ well (API No. 05-123-43474), the Wagner 2N-10HZ well (API No. 05-123-43471), the Wagner 27N-10HZ well (API No. 05-123-43470), the Wagner 1N-W10HZ well (API No. 05-123-43476), the Wagner 1N-E10HZ well (API No. 05-123-43475), and the Wagner 26C-10HZ well (API No. 05-123-43477), for the development and operation of the Niobrara and Codell Formations.
