APPLICATION

On July 13, 2017, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in three approximate 400-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Norden 1N-14HZ Well (API No. 05-123-43575) (Niobrara Formation - WSU #1), the Norden 27C-14HZ Well (API No. 05-123-43571) (Codell Formation - WSU #2), and the Norden 27N-14HZ Well (API No. 05-123-43574) (Niobrara Formation - WSU #3).


