NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 3 South, Range 64 West, 6<sup>th</sup> P.M.  
Section 32: All

APPLICATION

On July 17, 2017, Bison Exploration, LLC (Operator No. 10646) ("Bison" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S., for an order to:

- 1) Vacate the approximate 1280-acre drilling and spacing unit established by Order No. 535-531 for Sections 31 and 32, Township 3 South, Range 64 West, 6<sup>th</sup> P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 2) Establish one approximate 640-acre drilling and spacing unit for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, and approve up to sixteen horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation; and
- 3) Require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 460 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit.
- 4) Applicant states that the wells shall be drilled from no more than three wellpads within the unit, or from a legal location on adjacent lands, unless an exception is granted by the Director.

APPLICABLE RULES AND ORDERS

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. Section 31, Township 3 South, Range 64 West, 6<sup>th</sup> P.M. is subject to this Rule for the Niobrara Formation.

- On September 15, 2014, the Commission entered Order No. 535-531, which established one approximate 1280-acre exploratory drilling and spacing unit consisting of Sections 31 and 32, Township 3 South, Range 64 West, 6<sup>th</sup> P.M., and approved up to two horizontal wells within the unit, for production of oil, gas and associated hydrocarbons from the Niobrara Formation. Section 32, Township 3 South, Range 64 West, 6<sup>th</sup> P.M. are subject to this Order for the Niobrara Formation.


