APPLICATION

On October 6, 2017, Dan A. Hughes Company, L.P., Operator No. 10346 ("Company" or "Applicant"), filed an amended verified application for an order to:

- 1) Establish an approximate 160-acre exploratory drilling and spacing unit for the Application Lands, with the well to be located approximately 1670 feet from the east line of the proposed drilling and spacing unit, and approximately 1150 feet from the south line of the proposed drilling and spacing unit, *i.e.*, not less than 600 feet from any unit boundary, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply; and
- 2) Pool all interests in the Application Lands for the production of oil, gas, and associated hydrocarbons from the Lyons Formation, and subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the first well to the Lyons Formation.

- Rule 318.a of the Rules and Regulations of the Oil and Gas Conservation Commission provides that a well to be drilled two thousand five hundred (2,500) feet or greater shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply, unless authorized by order of the Commission upon hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 27, 2017.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
