APPLICATION

On August 31, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S. for an order to:

- 1) Pool all interests in an approximate 640-acre designated horizontal wellbore spacing unit, for the development and operation of the Niobrara formation; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in § 34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Bunting 26O-102 Well (API No. 05-123-44083) ("Well").

- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara formations, the Codell formation, and the Niobrara formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1.
- On June 30, 2011, the Commission entered Order Nos. 232-278 & 407-439, which, among other things, pooled all non-consenting interests in a 160-acre wellbore spacing unit for

the W½NW½ of Section 25 and the E½NE½ of Section 26, Township 5 North, Range 65 West, 6th P.M., for the Geib #41-26 well (API #05-123-32111), from the Codell, Niobrara, and "J" Sand formations. Order Nos. 232-278 & 407-439 are not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.

- On July 22, 2009, the Commission entered Order No. 407-334, which, among other things, pooled all non-consenting interests in a 160-acre wellbore spacing unit for the W½NW¼ of Section 30, Township 5 North, Range 64 West, 6th P.M., and the E½NE¼ of Section 25, Township 5 North, Range 65 West, 6th P.M., for the Conagra B #30-31D well (API #05-123-26997), from the Codell and Niobrara formations. Order No. 407-334 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.
- On August 27, 2009, the Commission entered Order No. 407-335, which, among other things, pooled all non-consenting interests in a 160-acre wellbore spacing unit for the SW¼NW¼ and NW¼SW¼ of Section 30, Township 5 North, Range 64 West, 6th P.M., and the SE¼NE¼ and NE¼SE¼ of Section 25, Township 5 North, Range 65 West, 6th P.M., for the Conagra B #30-32D well (API #05-123-26996), from the Codell and Niobrara formations, and a 160-acre wellbore spacing unit for the W½SW¼ of Section 30, Township 5 North, Range 64 West, 6th P.M., and E½SE¼ of Section 25, Township 5 North, Range 65 West, 6th P.M., for the Conagra B #30-33D well (API #05-123-28063), from the Codell and Niobrara formations. Order No. 407-335 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.
- On April 11, 2014, the Commission entered Order No. 407-986, which, among other things, pooled all non-consenting interests in a 320-acre wellbore spacing unit for the N½ of Section 25, Township 5 North, Range 65 West, 6th P.M., for the LaSalle 25F-332 well (API #05-123-37340), from the Niobrara formation. Order No. 407-986 is not affected by this Application, and proceeds from any shared lands will be accounted for in production of the Well.
- On November 7, 2016, the Commission entered Order No. 407-1818, which, among other things, established a 640-acre drilling and spacing unit for the N½ of Section 26 and the N½ of Section 27, Township 5 North, Range 65 West, for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell formations. The Commission vacated Order No. 407-1818 by Order No. 407-2089, which was entered on June 21, 2017.
