APPLICATION

On August 31, 2017, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S. for an order to:

- 1) Pool all interests in an approximate 640-acre designated horizontal wellbore spacing unit, for the development and operation of the Niobrara formation; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in § 34-60-116(7)(b), C.R.S. were first incurred for the drilling of the Bunting 26P-232 Well (API No. 05-123-44089) ("Well").

- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara formations, the Codell formation, and the Niobrara formation underlying certain lands, including the Application Lands, with the permitted well locations in accordance with the provisions of Order 407-1.
- On August 27, 2009, the Commission entered Order No. 407-335, which, among other things, pooled all non-consenting interests in a 160-acre wellbore spacing unit for the SW $\frac{1}{4}$ NW $\frac{1}{4}$  and NW $\frac{1}{4}$ SW $\frac{1}{4}$  of Section 30, Township 5 North, Range 64 West, 6<sup>th</sup> P.M.,

and the SE¼NE¼ and NE¼SE¼ of Section 25, Township 5 North, Range 65 West, 6<sup>th</sup> P.M., for the Conagra B #30-32D well (API #05-123-26996), from the Codell and Niobrara formations, and a 160-acre wellbore spacing unit for the W¼SW¼ of Section 30, Township 5 North, Range 64 West, 6<sup>th</sup> P.M., and E¼SE¼ of Section 25, Township 5 North, Range 65 West, 6<sup>th</sup> P.M., for the Conagra B #30-33D well (API #05-123-28063), from the Codell and Niobrara formations. Order No. 407-335 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.
