Township 7 South, Range 94 West, 6th P.M. Section 19: Lots 1-4, E1/2W1/2, E1/2 (a/d/a. All)

### APPLICATION

On August 31, 2017, Caerus Piceance LLC (Operator No. 10456) ("Caerus" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1. Vacate all 40-acre drilling and spacing units established by Order 139-73 for Section 19, Township 7 South, Range 94 West, 6th P.M.:
- Maintain 40-acre spacing within the NE¼NE¼ of Section 19, Township 7 South, Range 94 West, 6th P.M., for the Rulison Federal #19-41C (17M) Well only under Order 139-73 and exclude the Well from the proposed drilling and spacing unit; and
- Establish one approximate 600-acre drilling and spacing unit for the Application Lands allowing 10-acre bottomhole well density therein, for the production of oil, gas, and associated hydrocarbons from the Williams Fork and Iles Formations.
- Applicant stated that the wells will be drilled from no more than four well pads, to be located within such unit or adjacent thereto, unless an exception is granted by the Director.

 On May 10, 2007, the Commission entered Order 139-73, which, among other things. established various 40-acre drilling and spacing units for certain lands, including Section 19, Township 7 South, Range 94 West, 6th P.M., and approved the equivalent of one well per 10 acres within each 40-acre unit, for the production of oil, gas, and associated hydrocarbons from the Williams Fork and Iles Formations.
