APPLICATION

On August 31, 2017, SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Amend Pooling Order No. 407-1717 to pool all interests in the Wellbore Spacing Unit and establish the Application Lands (consisting of the Original and Additional Lands), for development and operation of the Niobrara Formation.

2. Providing that the interests of any owners within the Additional Lands with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Bestway 14-2-11-14CHZM Well, are made subject to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date the costs specified in §34-60-116(7)(b), C.R.S. are first incurred for the drilling of the Bestway 14-2-11-14CHZM Well.
