<u>APPLICATION</u>

On October 5, 2017, Airport Land Partners, Ltd., a Colorado Limited Partnership ("Airport Land"), by their attorneys, filed an Application for an Order Determining Whether the Commission has Jurisdiction Over Applicant's Royalty Underpayment Claims Against Antero Resources Corporation ("Antero") and Ursa Operating Company, LLC ("Ursa") pursuant to §34-60-118.5, C.R.S., and Rule 503.b.(10), for an order to:

- 1. Declare that the Commission does not have jurisdiction over the Airport Land's royalty underpayment claims against Antero and Ursa, and that such royalty underpayment claims should be determined in a district court lawsuit;
- 2. In the alternative, if the Commission decides to exercise jurisdiction over Airport Land's underpayment claims against Antero and Ursa, then the Commission should compel Antero, Ursa, and certain third parties to produce relevant documents and electronic data and set the parties' dispute for a hearing on the merits.

APPLICABLE STATUTE

- Section 34-60-118.5(5), C.R.S. provides that absent a bona fide dispute over the interpretation of a contract for payment, the Colorado Oil and Gas Conservation Commission has jurisdiction to determine the following:
 - (a) The date on which payment of proceeds is due a payee under section (2) of the section;
 - (b) The existence or nonexistence of an occurrence pursuant to subsection (3) of this section which would justifiably cause a delay in payment; and
 - (c) The amount of the proceeds plus interest, if any due a payee or payer.
- Section 34-60-118.5(5.5), C.R.S., provides that (5.5) before hearing the merits of any proceeding regarding payment of proceeds pursuant to this section, the oil and gas conservation commission shall determine whether a bona fide dispute exists regarding the interpretation of a contract defining the rights and obligations of the payer and payee. If the commission finds that such a dispute exists, the commission shall decline jurisdiction over the dispute and the parties may seek resolution of the matter in district court.

Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
