APPLICATION

On October 12, 2017, Renegade Oil & Gas Company, LLC (Operator No. 74165) ("Renegade" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 1,280-acre drilling and spacing unit covering the Application Lands for the production of oil, gas and associated hydrocarbons from the Niobrara Formation and approve a total of up to 16 horizontal wells within the unit;

2) Require the productive interval of the wellbore of each wellbore in the unit to be no closer than 150 feet from the productive interval of any other wellbore located in the unit and no closer than 300 feet from the northern, southern, and eastern unit boundaries and no closer than 100 feet from the western unit boundary, without exception being granted by the Director.

3) The Applicant states the proposed horizontal wells will be drilled from no more than two locations within the unit or at a legal location(s) on adjacent lands, without exception being granted by the Director.


