APPLICATION

On October 11, 2017, Captiva Energy Partners LLC (Operator No. 10658) ("Captiva" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in two approximate 160-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Stillroven Farm #3 Well (API No. 05-123-45410) (WSU #1) and the Stillroven Farm #4 Well (API No. 05-123-45404) (WSU #2) ("Subject Wells").


