APPLICATION

On October 11, 2017, Captiva Energy Partners LLC (Operator No. 10658) ("Captiva" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in four approximate 320-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Stillroven Farm #5 Well (API No. 05-123-45403) (WSU #1), the Stillroven Farm #6 Well (API No. 05-123-45407) (WSU #2), the Stillroven Farm #7 Well (API No. 05-123-45412) (WSU #3), and the Stillroven Farm #8 Well (API No. 05-123-45408) (WSU #4) ("Subject Wells").


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately 3 days before the hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original, and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 27, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
