On October 12, 2017, SRC Energy Inc., Operator No. 10311 ("SRC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in two approximate 805.4215-acre horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Donn 30N-20A-L Well, API No. to be assigned;
- b. Donn 30N-20B-L Well, API No. to be assigned.
