NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 4 South, Range 64 West, 6th P.M.

Section 14: All

Section 15: E½

APPLICATION

On or before October 12, 2017, ConocoPhillips Company (Operator No. 19160) and its wholly owned subsidiary Burlington Resources Oil & Gas LP (Operator No. 26580) (together, "COPC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in the Application Lands underlying an approximate 960-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation; and
- 2) Subject any non-consenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Snake 4-64 15-14 3AH well (API No. Pending); Snake 4-64 15-14 3BH well (API No. Pending), Snake 4-64 15-14 3CH well (API No. Pending), and Snake 4-64 15-14 3DH well (API No. Pending) ("Wells").

APPLICABLE ORDERS AND RULES

(available online at: <http://cogcc.state.co.us>, under "Regulation," then select "Orders" or "Rules")

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. The E½ of Section

15, Township 4 North, Range 64 West, 6th P.M. is subject to this Rule for the Niobrara Formation.

- On December 16, 2011 (Corrected July 12, 2012), the Commission entered Order No. 535-98, which approved up to two horizontal wells in an approximate 640-acre drilling and spacing unit covering all of Section 15, Township 4 South, Range 64 West, 6th P.M., and allowing for surface locations being located anywhere within Section 15 or surrounding lands but the lateral of such well may not enter the Niobrara Formation any closer than 300 feet from the section line, with treated interval of the permitted wellbore to be located no closer than 460 feet from the boundary of the section and no closer than 920 feet from the treated interval of any other well in the unit, without exception being granted by the Director.
- On October 1, 2012, the Commission entered Order No. 535-203 which, among other things, established two approximate 640-acre drilling and spacing units, and approved two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the productive interval of the horizontal wellbore to be no closer than 460 feet from the boundaries of the unit, and no closer than 920 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director. Section 14, Township 4 South, Range 64 West, 6th P.M. is subject to this Order for the Niobrara Formation.
- On January 7, 2013, the Commission entered Order No. 535-252 which pooled all interests in an approximate 640-acre drilling and spacing unit, established for Section 14, Township 4 South, Range 64 West, 6th P.M., to accommodate the Krout 14-1H Well, for the development and operation of the Niobrara Formation.
- On August 29, 2016, the Commission entered Order No. 535-738 which vacated Order No. 535-98, established an approximate 960-acre drilling and spacing unit for the Section 16 and the W½ of Section 15, Township 4 South, Range 64 West, 6th P.M., and approved up to three horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 300 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.
- On October 11, 2017, Applicant filed a Concurrent Spacing Application in Docket No. 171200818 to, among other things, establish an approximate 960-acre drilling and spacing unit for the Application Lands and approve four new horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S., and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:



One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 27, 2017, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
