NOTICE OF HEARING

APPLICATION

On October 12, 2017, Mallard Exploration, LLC (Operator No. 10670) ("Mallard" or "Applicant") filed a verified application pursuant to § 34-60-116 C.R.S. for an order to:

1. Amend Order 535-379 to include the Fort Hays, Codell, and Carlile Formations and approve up to four new horizontal wells within the unit, for the production of oil, gas, and associated hydrocarbons from the Fort Hays, Codell, and Carlile Formations;
2. Approve up to a total of 12 horizontal wells, in the an approximate 640-acre drilling and spacing unit established by Order No. 535-379 for the Application Lands, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation;
3. Require that the productive interval of each additional proposed horizontal well in the approximate 640-acre drilling and spacing unit shall be no closer than 600 feet from the boundaries of the unit and all horizontal wells shall be no closer than 150 feet from the productive interval of another well producing from the same source of supply within the unit, unless an exception is granted by the Director; and
4. Applicant stated that the wells will be drilled from no more than four well pads within the proposed drilling and spacing unit, to be located within such unit or adjacent thereto, unless an exception is granted by the Director.

- On July 29, 2013, the Commission entered Order 535-379, which among other things, established an approximate 640-acre drilling and spacing unit in Section 36, Township 8 North, Range 60 West, 6th P.M., and approved four horizontal well within the unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara Formation
- Rule 318.a. requires that wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and 1,200 feet from any other producible or

drilling oil or gas well that has the same common source of supply. The Application Lands are subject to this Rule for the Codell, Fort Hays, and Carlile Formations.

NOTICE IS HEREBY GIVEN, pursuant to §§ 34-60-101 to -130, C.R.S. and the Commission's Rules of Practice and Procedure, 2 CCR 404-1, that the Commission has scheduled this matter for hearing on:

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of January 15, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
