APPLICATION

On October 12, 2017, Highlands Natural Resources Corporation (Operator No. 10625) ("Highlands" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in an approximate 1,280-acre drilling and spacing unit established for the Niobrara Formation underlying the Application Lands; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Arrow 5-64 33-34-1CHZ Well, API No. Pending;
- b. Ulysses 5-64 33-34-1CHZ Well, API No. Pending;
- c. Bushnell 5-64 33-34-1BHZ Well, API No. Pending;
- d. Niagara 5-64 33-34-1BHZ Well, API No. Pending;
- e. Monitor 5-64 33-34-1BHZ Well, API No. Pending;
- f. Kiowa 5-64 33-34-1CHZ Well, API No. Pending;
- g. Heisshorn 5-64 33-34-1BHZ Well, API No. Pending;
- h. Arapahoe 5-64 33-34-1CHZ Well, API No. Pending;
- i. Ulysses 5-64 33-34-1CHZ Well, API No. Pending; and

- j. Any additional wells drilled in the drilling and spacing unit.

- On September 11, 2017, the Commission entered Order No. 535-845, which vacated a drilling and spacing unit established for Sections 34 and 35, Township 5 South, Range 64 West, 6th P.M., established an approximate 1,280-acre drilling and spacing unit for the Application Lands, and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation.
- On September 11, 2017, the Commission entered Order No. 535-847, which authorized an additional three horizontal wells, for a total of four horizontal wells, in the approximate 1,280-acre drilling and spacing unit established by Order No. 535-845 for the Application Lands, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated intervals of the horizontal wells to be no closer than 600 feet from the northern and southern boundaries of the unit, no closer than 460 feet from the eastern and western boundaries of the unit, and no closer than 150 feet from the treated interval of another well producing from the same formation, unless an exception is granted by the Director.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of November 27, 2017, if a prehearing conference**

is requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
