# **APPLICATION**

On or before November 30, 2017, GMT Exploration Company, LLC (Operator No. 10243) ("GMT" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,600-acre drilling and spacing unit for the Application Lands and approve up to sixteen (16) horizontal wells in the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation;
- 2) Provide that the productive interval any horizontal well shall be no closer than 600 feet from the boundaries of the unit and not less than 150 feet from the productive interval of another well within the unit, and authorizing up to three new well pads in the unit, or adjacent thereto, unless an exception is granted by the Director;
- 3) Find that an approximate 1,600-acre drilling and spacing unit for the development of the Niobrara Formation on the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Niobrara Formation in the Application Lands; and
- 4) For such other findings and orders as the Commission may deem proper or advisable in this matter.

 Rule 318.a. of the Commission Rules requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply. The Application Lands are subject to this Rule for the Niobrara Formation.
