APPLICATION

On November 30, 2017, Bayswater Exploration & Production, LLC (Operator No. 10261) ("Bayswater" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 640-acre drilling and spacing unit for the Application Lands, and approve up to eight (8) horizontal wells within the unit, for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations; and

2) Require the productive interval of the wellbore of any permitted wells in the unit to be located no closer than 150 feet from the treated interval of any other wellbore producing from the Codell and/or Niobrara formations, and no closer than 460 feet from the unit boundary, without exception being granted by the Director.

3) Applicant states that the wells will be drilled from no more than one well pad located within the unit and/or from a legal location on adjacent lands, without exception granted by the Director.
