On January 18, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) (“Extraction” or “Applicant”) filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in four approximate 321.5415-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Jesser 3E-10-7N Well (API No. 05-123-45662);
- b. Jesser 3E-10-8N Well (API No. 05-123-45673);
- c. Jesser 3E-10-9C Well (API No. 05-123-45659);
- d. Jesser 3E-10-10N Well (API No. 05-123-45665).
