On January 18, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in three approximate 400-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Trott 8E-10-7C Well (API No. 05-123-45731);
- b. Trott 8E-10-9N Well (API No. 05-123-45723);
- c. Trott 8E-10-11N Well (API No. 05-123-45712).


