APPLICATION

On January 18, 2018, Bill Barrett Corporation (Operator No. 10071) ("BBC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1. Maintain an approximate 640-acre drilling and spacing unit established by Order Nos. 535-4 and 407-779 for Section 1, Township 4 North, Range 61 West, 6<sup>th</sup> P.M. only for the existing production of oil, gas and associated hydrocarbons from the Niobrara Formation;

2. Maintain Order No. 535-392, which pooled all interests within an approximate 640-acre drilling and spacing unit established for Section 1, Township 4 North, Range 61 West, 6<sup>th</sup> P.M., to accommodate the drilling of the East Platte #1-01H Well, for the development and operation of the Niobrara Formation;

3. Establish an approximate 1,312.63-acre drilling and spacing unit for Sections 1 and 2, Township 4 North, Range 61 West, 6<sup>th</sup> P.M., and approve the drilling of up to eight (8) horizontal wells within the proposed unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations;

4. Provide that the productive interval of any horizontal well shall be no closer than 460 feet from the unit boundaries, and not less than 150 feet from the productive interval of another well within the unit, and authorizing up to four (4) new well pads within the unit, or adjacent thereto, unless an exception is granted by the Director;

5. Find that the approximate 1,312.63-acre drilling and spacing unit for the development of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations underlying the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Codell and Niobrara Formations in the Application Lands; and

6. For such other findings and orders as the Commission may deem proper or advisable in this matter.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. The Application Lands are subject to this Rule for the Niobrara and Codell Formations.
- On February 22, 2011 (Corrected April 4, 2013), the Commission entered Order Nos. 407-779 & 535-4 which, among other things, established 74 approximate 640-acre drilling and spacing units, and approved one horizontal well within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation. Section 1, Township 4 North, Range 61 West, 6<sup>th</sup> P.M. is subject to this Order for the Niobrara Formation.
- On July 29, 2013, the Commission entered Order Nos. 407-845 & 535-392 which pooled all interests within an approximate 640-acre drilling and spacing unit established for Section 1, Township 4 North, Range 61 West, 6<sup>th</sup> P.M., to accommodate the drilling of the East Platte #1-01H Well, for the development and operation of the Niobrara Formation.

One electronic ([cogcc.hearings\\_unit@state.co.us](mailto:cogcc.hearings_unit@state.co.us)), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of March 5, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.**

Pursuant to Rule 511, if the matter is uncontested, it may be approved without a hearing.
