On January 18, 2018, Ward Petroleum Corporation, Operator No. 10359 ("Ward" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate an approximate 480-acre drilling and spacing unit established by Order 407-2054, establish an approximate 1,280-acre drilling and spacing unit for Sections 1 and 12, Township 1 South, Range 68 West, 6th P.M., and approve up to 22 horizontal wells within the unit, for production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations; and
- 2) Require the productive intervals of the wellbore to be located no closer than 460 feet from unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located in the unit, unless an exception is granted by the Director.
- 3) Applicant states that the proposed wells to the newly created unit will be located on no more than two multi-well pads within or without the unit, subject to Rule 318A, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On June 12, 2017, the Commission entered Order No. 407-2054, which established an approximate 480-acre drilling and spacing unit in the SW¼ of Section 1 and the W½ of Section 12, Township 1 South, Range 68 West, 6th P.M., and authorized the drilling of up to 12 horizontal wells in such unit to the Codell or Niobrara Formations.
