1) Pool all interests in two approximate 620.966-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara Formation; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Milkshake 31W-20-1N (API No. 05-123-46054);
- b. Milkshake 31W-20-2N Well (API No. 05-123-46055).
