APPLICATION

On January 18, 2018 (amended on January 30, 2018), Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Pool all interests in six approximate 707.2438-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Codell and Niobrara Formations; and

2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Mickey 6 Well (API No. 05-123-43849);
- b. Mickey 7 Well (API No. 05-123-43857);
- c. Mickey 8 Well (API No. 05-123-43856);
- d. Mickey 9 Well (API No. 05-123-43846);
- e. Mickey 10 Well (API No. 05-123-43847);
- f. Mickey 11 Well (API No. 05-123-43848).
