- 1) Pool all interests in two approximate 200-acre designated horizontal wellbore spacing units and two approximate 400-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara Formation; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:

- a. Azul 13-6HZ Well (API No. 05-123-45912);
- b. Azul 13-7HZ Well (API No. 05-123-45911);
- c. Azul 13-8HZ Well (API No. 05-123-45910); and
- d. Azul 13-10HZ Well (API No. 05-123-45918).
