APPLICATION

On January 22, 2018, Crestone Peak Resources Operating LLC (Operator No. 10633) ("Crestone Peak" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Approve up to 40 horizontal wells in an approximate 1,920-acre drilling and spacing unit requested in Docket No. 170900522 for the Application Lands, for the production of the Codell and Niobrara Formations in the unit.
- 2) Providing that the productive interval of any horizontal well shall be no closer than 460 feet from the unit boundaries, and not less than 150 feet from the productive interval of another well within the unit, unless an exception is granted by the Director.
- 3) Finding that approval of 40 wells within the approximate 1,920-acre drilling and spacing unit for the development of oil, gas, and associated hydrocarbons from the Codell and Niobrara Formations underlying the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Codell and Niobrara Formations in the Application Lands.
- 4) For such other findings and orders as the Commission may deem proper or advisable in this matter.
- 5) Applicant is filing this increased density Application, separate from the Amended spacing application in Docket No. 170900522, after consultation with the City and County of Broomfield on certain allegations in its Protest. Applicant does not agree that this separate increased density filing is required by current Colorado law and reserves its right to assert its position on such amendment at hearing, if necessary.

- On February 19, 1992, the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for vertical and/or directional wells for the production of oil and/or gas from the Codell-Niobrara Formations. The Application Lands are subject to Order No. 407-87 as it applies to the existing vertical and/or directional well development and operation of the Codell and Niobrara Formations on the Application Lands.
- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area, Special Well Location, Spacing and Unit Designation Rule. The Application Lands are within the Greater Wattenberg Area ("GWA") and thus are subject to Rule 318A.
- In order to promote efficient drainage within the Codell and Niobrara Formations of the Application Lands, to protect correlative rights, to avoid waste, and to minimize surface impacts, Applicant, after consultation with the City and County of Broomfield as a Protestant, filed an Amended Application in Docket No. 170900522 requesting that Commission establish an approximate 1,920-acre drilling and spacing unit for one (1) horizontal well for Sections 22: E½, 23, 26 and 27: E½, Township 1 North, Range 68 West, 6th P.M., Weld and Broomfield Counties, Colorado for the efficient and economic development and operation of the Codell and Niobrara Formations.
