The Application Lands are subject to this Order for the Niobrara Formation.
- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area. Special Well Location, Spacing and Unit Designation Rule. The Application Lands are within the Greater Wattenberg Area ("GWA") and thus are subject to Rule 318A.
