APPLICATION

On February 27, 2018, Nickel Road Operating LLC (Operator No. 10669), together with Nickel Road FW LLC, an affiliate of Nickel Road Operating LLC under common ownership and control (together, "Nickel Road" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 1,280-acre drilling and spacing unit for Sections 9 and 10, Township 7 North, Range 65 West, 6th P.M., and approve up to 24 new horizontal wells in the proposed approximate 1,280-acre drilling and spacing unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations.

2) Provide that the productive interval of each proposed horizontal well shall be no closer than 460 feet from the boundaries of the proposed unit, and all horizontal wells shall be no closer than 150 feet from the productive interval of another well producing from the same supply within the unit, unless a waiver or consent is obtained from the operator of such well.

3) Providing that no more than two new well pads be approved in the unit, or adjacent thereto, unless an exception is granted by the Director.

4) Finding that the approximate 1,280-acre drilling and spacing unit for the development of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations underlying the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Niobrara and Codell Formations.

5) For such other findings and orders as the Commission may deem proper or advisable in this matter.
