APPLICATION

On March 1, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116(6) and (7), C.R.S., for an order to:

- 1) Pool all interests in five approximate 320-acre designated horizontal wellbore spacing units for the Application Lands for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations;
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the WS-Sunrise 1-5-5 Well (API No. 05-123-46047), the WS Sunrise 2-5-5 Well (API No. 05-123-46048), the WS Sunrise C1-5-5 Well (API No. 05-123-46045), the WS Sunrise 4-5-5 Well (API No. 05-123-46049), and the WS Sunrise 5-5-5 Well (API No. 05-123-46052) ("Wells").

- On April 27, 1988, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule, which was amended on August 8, 2011 to, among other things, address the drilling of horizontal wells and requires that a horizontal wellbore spacing unit must include any governmental quarter-quarter section that are located less than 460' from the completed interval of the wellbore lateral. Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of the Greater Wattenberg Area.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
