On March 1, 2018, Enerplus Resources (USA) Corporation (Operator No. 10177) ("Enerplus" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Declare Order No. 535-935, pooling all interests in an approximate 640-acre drilling and spacing unit established for the Application Lands applicable to all previously unnoticed parties.

- On January 29, 2018, the Commission entered Order No. 535-935 which, among other things, pooled all interests in an approximate 1,280-acre drilling and spacing unit for the Application Lands, for the development and operation of the Niobrara, Fort Hays, Codell, and Carlile Formations, and to subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Ballyshannon 8-67-26-23N Well (API No. 05-123-44923), the Benroe 8-67-26-23N Well (API No. 05-123-44922), the Carrick 8-67-26-23C Well (API No. 05-123-44925), the Cloghfin 8-67-26-23C Well (API No. 05-123-44926), the Donegal 8-67-26-23C Well (API No. 05-123-44919), the Killybegs 8-67-26-23C Well (API No. 05-123-44928), the Lough Erne 8-67-26-23C Well (API No. 05-123-44931), and the Sligo 8-67-26-23C Well (API No. 05-123-44921).


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately 3 days before the hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of April 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
