Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Bath-Schmier 1C Well (API No. 05-123-45072), the Bath-Schmier 2N Well (API No. 05-123-45077), the Bath-Schmier 3N Well (API No. 05-123-45078), and the Bath-Schmier 4N Well (API No. 05-123-45074) ("Wells").
