APPLICATION

On May 31, 2018, Noble Energy, Inc., (Operator No. 100322) ("Noble" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Amend Pooling Order No. 407-2275, only as to WSU No. 1, pooling all interests in an approximate 722-acre drilling and spacing unit established for the Application Lands, for the development and operation of the Niobrara Formation rather than the Codell Formation, effective as of the earlier of the date of Pooling Order No. 407-2275, or the date the costs specific in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Centennial State G34-612 Well.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On or about December 11, 2017, the Commission entered Order No. 407-2275, which, among other things, pooled all interests in an approximate 722-acre designated horizontal wellbore spacing unit and an approximate 360-acre designated horizontal

wellbore spacing unit established for certain portions of Sections 1, 2, and 3, Township 3 North, Range 65 West, 6th P.M. and Sections 34, 35, and 36, Township 4 North, Range 65 West, 6th P.M., for the development and operation of the Niobrara and Codell Formations
