#### APPLICATION

On April 24, 2018 (amended April 30, 2018), CCRP Operating Inc. (Operator No. 10665) ("CCRP" or "Applicant"), filed a verified amended application ("Application") pursuant to §34-60-116, C.R.S., for an order:

- 1) Amending Order No. 535-617 to establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, and authorize the drilling of 14 horizontal wells within the proposed unit, for the production of oil, gas and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations, with the treated interval of any horizontal well permitted under this Application located not less than 300 feet from unit boundaries and not less than 150 feet from any other well producing or drilling from the Niobrara, Fort Hays, Codell, and/or Carlile Formations, without exception being granted by the Director.
- 2) Limiting the drilling of any permitted wells under this Application to no more than four multi-well pads within the drilling and spacing unit, or on adjacent lands with surface owner consent, without exception being granted by the Director.

## **APPLICABLE ORDERS AND RULES**

 COGCC Rule 318.a. provides that for any oil or gas well drilled to a common source of supply and drilled to a producing depth at least 2,500 feet below ground surface shall be located not less than 600 feet from any leaseline and not less than 1,200 feet from any other producing or drilling oil or gas well when drilling to the same source of supply, unless authorized by Commission order upon hearing. The Application Lands are subject to this Rule for production of oil and gas from the Niobrara. Fort Hays and Carlile Formations.  On January 26, 2015, the Commission issued Order No. 535-617 which, among other things, established an approximate 1,280-acre drilling and spacing units for the Application Lands, and approved four horizontal wells within said unit, for the production of oil, gas and associated hydrocarbons from the Codell Formation, with the treated interval of any permitted well located not less than 300 feet from unit boundaries and not less than 600 feet from any other well or treated interval of a well producing from the Codell Formation.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of September 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
