APPLICATION

On April 30, 2018, Noble Energy, Inc. (Operator No. 100322) ("Noble" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Establish an approximate 2,240-acre drilling and spacing unit for the Application Lands for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations;
- 2) Approve up to 21 new wells in the proposed approximate 2,240-acre drilling and spacing unit for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations;
- 3) Require that the productive interval of each proposed horizontal well shall be no closer than 460 feet on the eastern, western and southern boundaries of the proposed unit, and no closer than 120 feet from the northern boundaries of the proposed unit and all horizontal wells shall be no closer than 120 feet from the productive interval of another well producing within the same unit, unless a waiver or consent is obtained from the operator of such well, unless an exception is granted by the Director;
- 4) Provide that any permitted wells shall be drilled in a south-north orientation;
- 5) For such other findings and orders as the Commission may deem proper or advisable in this matter.

- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87 which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations, with permitted well locations in accordance with the provisions of Order No. 407-1. The Application Lands are subject to this Order for the Niobrara Formation.
- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area, Special Well Location, Spacing and Unit Designation Rule. The Application Lands are within the Greater Wattenberg Area ("GWA") and thus are subject to Rule 318A.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
