# NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

#### **APPLICATION LANDS**

Township 9 North, Range 60 West, 6<sup>th</sup> P.M. Section 8: All

### <u>APPLICATION</u>

On May 4, 2018, Bison Oil & Gas II, LLC (Operator No. 10661) ("Bison" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Modify an approximate 640-acre drilling and spacing unit established by Order No. 535-69 for the Application Lands to include the Fort Hays, Codell, and Carlile Formations, and to approve up to 20 horizontal wells within the unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formation:
- 2) Establish well location rules such that the treated interval of each wellbore within the unit is no closer than 600 feet from the unit boundary, and no closer than 165 feet from the productive interval of any other wellbore located within the unit; and
- 3) Require the wells to be drilled and operated from no more than two surface locations within the unit or on adjacent lands.

- Rule 318.a. of the Rules and Regulations of the Oil and Gas Conservation Commission requires that, on unspaced lands, wells drilled in excess of 2,500 feet in depth be located not less than 600 feet from any lease line, and located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same common source of supply.
- On September 19, 2011, the Commission entered Order No. 535-69, which established 40 approximate 640-acre drilling and spacing units for certain lands in Townships 7, 8, and 9, North, Ranges 58 through 61 West, 6<sup>th</sup> P.M., and approved two horizontal wells within each unit, for the production of oil, gas, and associated

hydrocarbons from the Niobrara Formation, with the treated interval of the wellbores to be located no closer than 600 feet from the unit boundaries, and no closer than 150 feet from any existing or permitted oil or gas wellbore, without exception being granted by the Director.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
