NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

APPLICATION LANDS

Township 8 North, Range 60 West, 6<sup>th</sup> P.M.  
Section 16: All

On May 16, 2018, (amended May 21, 2018), Mallard Exploration, LLC (Operator No. 10665) and Noble Energy, Inc. (Operator No. 100322) (together as Co-Applicants), filed a verified application ("Application"), pursuant to §34-60-116, C.R.S., for an order to:

1) Establish an approximate 640-acre drilling and spacing unit for the Application Lands, and approve the drilling of 16 horizontal wells within said unit, for production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations, with the treated interval of any (regardless of lease lines within the unit), unless an exception is granted by the Director, and all horizontal wells shall be no closer than 150 feet from the productive interval of another well producing from the same supply within the unit, unless a waiver or consent is obtained from the operator of such well.

2) Limit the drilling of any permitted wells under this Application to no more than two new well pads in the unit, or on lands adjacent thereto with surface owner consent, unless an exception is granted by the Director.

3) Maintain allocation of payment of proceeds for the State 8-60 16-1H and State 8-60 16-2H Wells drilled within Section 16, Township 8 North, Range 60 West, 6th P.M., and producing oil, gas, and associated hydrocarbons from the Niobrara Formation.

- COGCC Rule 318.a. provides that for any oil or gas well drilled to a common source of supply and drilled to a producing depth at least 2,500 feet below ground surface shall be located not less than 600 feet from any lease line and not less than 1,200 feet from any other producing or drilling oil or gas well when drilling to the same source of supply, unless approved by Commission order upon hearing. The Application Lands are subject to this Rule for production of oil and gas from the Codell, Fort Hays, Carlile, and Niobrara Formations.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of July 16, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
